

RESOLUTION 2-2021

**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO
AN AGREEMENT WITH SUVON, LLC D/B/A FIRSTENERGY ADVISORS
REGARDING ELECTRIC ENERGY CONSULTING SERVICES
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Marblehead desires to engage Suvon, LLC d/b/a FirstEnergy Advisors (hereinafter "Suvon") to render certain energy consulting services with regard to electric energy related matters within the Village; and,

WHEREAS, Suvon is willing to provide said energy consulting services for the consideration upon the terms and conditions of an Agreement, substantially similar to the one attached hereto as Exhibit A; and,

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the Village to collaborate with the Suvon as to electric energy consulting services related matters within the Village.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Marblehead, Ottawa County, Ohio, that:

Section 1. The Mayor and Fiscal Officer are hereby authorized to execute an Agreement with Suvon, LLC Advisors d/b/a FirstEnergy Advisors pertaining to electric energy consulting services, in a form substantially similar to the agreement attached hereto as Exhibit "A."

Section 2. That the Mayor and Fiscal Officer are hereby authorized and directed to do all things necessary to effectuate the entering of, execution and implementation of said agreement.


Section 3. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 4. That, to the extent not already done so, the funds required for the payment of the obligations incurred are hereby appropriated for the purposes described.


Section 5. That it is found and determined that all formal actions of the Council relating to the adoption of this Resolution were taken in a duly noticed virtual, open meeting of this Council and that all deliberations which resulted in formal action were taken in meetings open to the public, in full compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code and HB 197 during the state-declared COVID-19 emergency.

Section 6. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the Village's residents because this contract must be signed as soon as possible in order to find the best supplier of electricity for the Village before the May contract ends, and shall, therefore, take effect and be in force from and immediately after its passage.
