

**RESOLUTION NO. 2-2018**

**A RESOLUTION BY THE COUNCIL OF THE VILLAGE OF MARBLEHEAD  
DECLARING THE AMOUNT OF TAXES THAT MAY BE RAISED BY LEVY AT  
THE MAXIMUM RATES AUTHORIZED BY LAW WITHOUT THE VOTE OF THE  
ELECTORS TO BE INSUFFICIENT AND DECLARING THE NECESSITY OF A  
RENEWAL LEVY IN EXCESS OF SUCH RATES**

**WHEREAS**, the Village Council has determined that the amount of taxes that may be raised inside the 10-mill limitation is insufficient to provide an adequate amount to meet the Village of Marblehead's current expenses; and

**WHEREAS**, there is currently a 2.0 mill levy to provide funds for current expenses; and

**WHEREAS**, there is a need to renew the existing 2.0 mill levy with an additional 0.2 mill increase; and

**WHEREAS**, the County Auditor has certified to Council that the dollar amount of revenue that would be generated by the Renewal Levy during the first year of collection is \$247,440; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MARBLEHEAD, OHIO, OTTAWA COUNTY, OHIO:**

**SECTION 1.** That the amount of taxes that may be raised by the levy of taxes within the ten (10) mill limitation and that the maximum rate authorized by a statute on the taxable property in said Village of Marblehead, Ohio, will be insufficient to provide an adequate amount for the necessary requirements of said Village and that it is necessary for the purpose of providing for additional funds pursuant to R.C. 5705.19(A) for the purposes of current expenses, that a renewal of said tax with an additional 0.2 mill increase be levied on the taxable property in said Village for a period of five (5) years as authorized by R.C. 5705.19 at a rate in excess of such maximum rate authorized by statute.

**SECTION 2.** Such Renewal Tax Levy shall be for five (5) years and at a rate not to exceed two and 2/10ths (2.2) mills for each One Dollars (\$1.00) of the tax valuation or \$.22 for each One Hundred Dollars (\$100.00) of the tax valuation of the taxable property within the Village of Marblehead, Ohio, in excess of the rate authorized by statute.

**SECTION 3.** That the question of the 2.0 mill renewal with an additional .2 mill increase of such levy shall be submitted to the electors of the Village of Marblehead, Ottawa

County, Ohio, for their approval or rejection, at the Primary Election to be held on the 8<sup>th</sup> day of May, 2018.


**SECTION 4.** Such tax levy shall be placed upon the tax list and duplicate for the current tax year beginning in 2018, first due in calendar year 2019, if a majority of the electors voting thereon in favor thereof.

**SECTION 5.** That the Fiscal Officer of said Village of Marblehead, Ohio, be and she is hereby, directed to certify a copy of this Resolution to the Board of Elections of Ottawa County, Ohio, in order that said Board of Elections may take the necessary arrangements for the submission of such questions to the electors of said Village of Marblehead, Ohio at the Primary Election in said Village to be held as aforesaid.

**SECTION 6.** That this Council hereby finds and determines that all formal actions relative to the adoption of the Ordinance were taken in an open meeting of this Council; and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including R.C. §121.22.

**SECTION 7.** That pursuant to law, this Resolution shall be into effect immediately.
