**RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE  
BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND  
CERTIFYING THEM TO THE COUNTY AUDITOR**

*The Council of the Village of Marblehead, Ottawa County, Ohio, met in regular session on the 11th day of September, 2019, at the Marblehead Village Fire Station with the following members present: Mr. E. Lynn App, Mr. Dean Dorko, Mrs. Angie Kukay, Mr. Duane Myers and Mr. John Starcher.*

Mr. /Mrs. Myers moved the adoption of the following Resolution:

*WHEREAS, the Council, in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1<sup>st</sup>, 2020; and*

*WHERE AS, the Budget Commission of Ottawa County, Ohio, has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within, the ten mill tax limitation; therefore, be it*

*RESOLVED, By the Council of the Village of Marblehead, Ottawa County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further*

*RESOLVED, That there be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation as follows:*
